

Independent Institutional Verification Worksheet (Group 4)

Your 2021-2022 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. Sterling College will maintain a copy of the photo identification with the date received and name of official authorized to collect the student ID and notary certification will NOT be required.

Identity and Statement of Educational Purpose (To Be Signed at the Institution)
